- E. The Court has also determined that a statutory declaration received on behalf of two group members listed in Annexure B, is defective in that it:
  - a. was only signed by one group member, despite purporting to be on behalf of both; and
  - b. does not disclose a valid reason for the failure to lodge an Opt Out Form prior to the Class Deadline.
- F. The Court provided the group members in Annexure B the opportunity to provide further reasons for their failure to lodge Opt Out Forms prior to the Class Deadline in separate statutory declarations, however no response has been received by the Court as at the date of this order.
- G. In these circumstances, the Court does not consider it appropriate at this juncture to make any order in relation to the group members in Annexure B.
- H. This order is signed by the Judge pursuant to r 60.02(1)(b) of the *Supreme Court (General Civil Procedure) Rules 2015*.

## THE COURT ORDERS THAT:

1. The individuals in Annexure A cease to be group members in this proceeding pursuant to s 33KA of the *Supreme Court Act 1986* (Vic).


